**Objectives of This Memorandum of Understanding**


1. To familiarize students with the Hospital and the work that is done there.

8. The MOU can be renewed with mutual permission and is valid for **Five (05) years** from the date of signature.

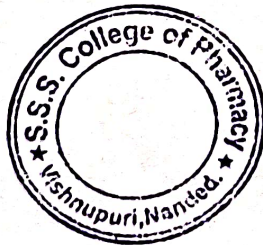
