The Principal, College of Pharmacy, Vishnupuri, Dist. Nanded-431606 mutually coordinate and to oversee the implementation of this agreement.


Now This Memorandum of Understanding Witnessed as Under

In witness whereof the parties herein above have signed and executed the above MOU on the 17th August 2024 herein above mentioned in the presence of the following witnesses.




